

On both aften offers were made on one or two items which are also the subject of negotietions with other countries.

The negotiations between Finland and Australia may be regarded as concluded although, on the Australian alde, the offers have been made subject to confirmation by Canberra.

We propose to defer formal circulation of the Auntralian offer until confirmation is received from Canborra.




