

MEMORANDUM:

In conformity with the procedure prescribed in GATT/TN.1/A/1 the Australian Delegation wishes to inform the Secretariat that representatives of Australia and Uruguay met at 10 a.m. on 6th May and held exploratory talks as scheduled.

Whilst it was agreed that in view of the small volume of trade which is normally done between the two countries, it was very doubtful whether a basis existed for negotiations, it was also decided to defer a final decision until the representatives consulted their respective governments on some points that arose in the course of the discussions.

No date was fixed for the second talk, which will probably also be the final talk, but it is anticipated that it will not be delayed longer than 14 days.


We have the honour to inform you that negotiations with Australia took place on the 6th. of May 1949 at which time, after a careful analysis of the trade situation,
