The attached statement of offers by the Indian
Delegation in respect of requests made by Denmark, is
presented in two Sections.

Section I includes concessions made by India during the
Tariff Negotiations at Geneva in 1947 on items
of interest to Denmark. India has extended to
Denmark the benefits of these concessions since
1947 and now seeks compensating concessions.

Section II shows the responses which India is prepared to
make to the requests made by Denmark for further
concessions on the Indian Tariff.




