Such public notice is required under the Trade Agreements Act of 1934, as amended and extended, the legislative authority under which the United States undertakes these tariff negotiations.

Reductions in duty will be made in three annual stages, the first stage to become effective not later than June 30, 1956. In the event that any specified rate becomes effective and subsequently becomes ineffective by reason of action taken pursuant to paragraph 3(ii) of the said Protocol of Supplementary Concessions or any other reason, the later stages of reductions will not be made effective until the rate which became ineffective has been restored and has been in effect for a total period of one year.
