Methodological Recommendations on Determination of the Origin of Goods from the Special Economic Zone in the Magadan Oblast

- 1. The origin of goods from the Special Economic Zone shall be confirmed by the certificate of origin of goods from the Special Economic Zone (hereinafter referred to as the certificate) issued by the Magadan Chamber of Commerce and Industry (MCCI) in accordance with the established format (attached).
- 2. Validity of the information about the goods contained in the certificate shall be confirmed by the chief executive officer of the organization shipping the goods in question.
- 3. The certificate shall be confirmed by the Chairman of the Magadan Chamber of Commerce and Industry or an MCCI official duly authorized to issue certificates, sealed with the MCCI official seal, and registered with the MCCI.
- The original certificate shall be submitted to the customs authority of the 4. Russian Federation. If the original is lost, its officially certified copy shall be submitted. Goods shall not be considered as having been originated from the Special Economic Zone until a duly issued certificate to that effect is submitted. In case of motivated doubts as to the authenticity of a certificate or information contained therein, including the information on the origin of goods, the customs authority shall have the right to independently check the information contained in the certificate (including by physically checking the goods). When goods are taken out of the territory of the Special Economic Zone in the Magadan Oblast, customs authorities shall issue to participants of foreign economic relations a copy of the certificate certified by a duly authorized official. Organizations producing constant assortment of goods may be issued a General Certificate of the origin of goods from the Special Economic Zone of the Magadan Oblast covering the entire range of goods produced by such organizations valid for a period of up to one year.
