

**DECISION OF THE GOVERNMENT OF THE RUSSIAN FEDERATION NO. 166 OF MARCH 29, 2005
ON AMENDING THE CUSTOMS TARIFF OF THE RUSSIAN FEDERATION WITH RESPECT TO
MOTOR COMPONENTS IMPORTED FOR INDUSTRIAL ASSEMBLY (with the Amendments and
Additions of November 27, 2006)**

The Government of the Russian Federation resolves as follows:

1. Abolished from January 1, 2007.

2. The Ministry of Economic Development and Trade of the Russian Federation shall elaborate jointly with the Ministry of Industry and Energy of the Russian Federation and the Ministry of Finance of the Russian Federation and approve before April 15, 2005 the procedure defining the notion "industrial assembly" and the conditions for the application of the indicated notion in the importation of motor components for the manufacture of motor transport vehicles of headings 8701 - 8705 of the CC FEA, their units and sets.

3. To replace in Annex No. 2 to the Regulations on the Procedure for the Importation into and Exportation from the Russian Federation of Ozone Destroying Substances and Products Containing Them, approved by Decision of the Government of the Russian Federation No. 563 of May 8, 1996 on the Regulation of the Importation into and Exportation from the Russian Federation of Ozone Destroying Substances and Products Containing Them (Sobraniye Zakonodatelstva Rossiyskoy Federatsii, 1996, No. 20, item 2353; 1997, No. 8, item 943; No. 47, item 5409; 2000, No. 9, item 1036; 2001, No. 50, item 4735), code: "from 3910 00 000 0" with code: "from 3910 00 000" and code: "from 8415 20 000 0" with code: "from 8415 20 000".

4. To replace in the List of Goods (Equipment, Including Accessories and Spare Parts Thereof) Imported (Being Imported) into the Customs Territory of the Russian Federation under Agreements (Arrangements, Contracts) Whose Financing Had Been Opened before August 1, 1998 Inclusive and Was Carried Out at the Expense of Tied Credits of the Governments of Foreign States, Banks and Firms Attracted against Guarantees of the Government of the Russian Federation, approved by Decision of the Government of the Russian Federation No. 626 of October 14, 2003 on the Exemption from the Importation with the Customs Duty of Certain Goods (Equipment, Including Accessories and Spare Parts Thereof) (Sobraniye Zakonodatelstva Rossiyskoy Federatsii, 2003, No. 42, item 4076; 2004, No. 33, item 3493), code: "4016 93 900 0" with code: "4016 93 900", code: "7320 20 810 0" with code: "7320 20 810", code: "7320 20 890 0" with code: "7320 20 890", code: "8483 10 510 0" with code: "8483 10 510" and code: "8483 30 900 0" with code: "8483 30 900".

5. This Decision shall enter into force from the day of its official publication, except for Items 1, 3 and 4, which shall enter into force as of April 15, 2005.
