## SOUTH AFRICAN IMPORT RESTRICTIONS

### Deletions from the Restricted List, 22 May 1964

In a press statement circulated in L/2210 of 17 April 1964 it was announced inter alia that certain items were being removed from the restricted list. The South African Government has now submitted for the information of contracting parties an import control notice of 22 May 1964 implementing that decision which relieves South African importers who have suitable valid import permits of the need to obtain specific permits in order to import the goods subject to this notice. The explanatory note to the list of products which are to enjoy this more favourable import treatment and the list are as follows:

Explanatory Note: The effect of this notice is that the goods mentioned herein may, after the date of publication of this notice, be imported into the Republic of South Africa, provided the importer is in possession of a suitable valid import permit. Importers wishing to import any of the goods detailed in this notice need therefore no longer convert their import permits into specific permits (in which the goods to be imported are specifically described).
