Addendum

Scale of Contributions

In accordance with paragraph 4 of the Draft Resolution on the Expenditure of the CONTRACTING PARTIES in 1965 and the Ways and Means to meet such Expenditure (document L/2269, page 8) two scales of contributions are submitted herewith. Scale I includes a provision of \$145,000 covering the residual payment for the construction of the second Annex in the event that the loan requested from the Swiss Government should not be granted, and Scale II excludes such provision. The scale to be applied will depend on the decision to be taken in December by the Swiss Parliament as to the granting of the loan.

The estimated shares of Belgium and Luxemburg have been provisionally retained in the attached scales pending receipt of additional information concerning the value of trade of these two countries.

In certain cases the trade figures have been revised to take account of the 1963 trade data which could not be obtained when the draft scale attached to document L/2246 was prepared.
