## CENTRAL AMERICAN COMMON MARKET

### Alignment of Bound Duties in Schedule XXIX - Nicaragua

### Request for extension of Decision of 23 November 1961<sup>1</sup>

In accordance with its undertaking in L/2256 the Government of Nicaragua has presented the information annexed hereto, relating to the process of alignment of the tariff items it has bound in Schedule XXIX with the customs tariff of the Central American customs union.

The Government of Nicaragua calls the attention of the CONTRACTING PARTIES in particular to the fact that the alignment of bound duties has on the whole resulted in a reduction rather than an increase in duties.

It will be seen, however, that although very substantial progress has been made in the process of alignment, some items remain to be negotiated with the other members of the Common Market.

Since negotiations on these remaining items are being actively pursued between Nicaragua and her partners, the Government of Nicaragua considers that the renegotiations under Article XXVIII of GATT, provided for in the Decision of 23 November 1961, would be more conveniently and appropriately conducted when this process will have been concluded.

The Government of Nicaragua accordingly requests that the CONTRACTING PARTIES extend the Decision of 23 November 1961 for a further three years, by which time the process of alignment will have been concluded.

In making this request the Government of Nicaragua wishes to reiterate its firm intention to conduct these renegotiations in accordance with the terms and conditions of the above-mentioned Decision.

ANNEX

Comparison of GATT Schedule XXIX - Nicaragua, with the  
Common External Tariff of the Central American Common Market

The attached tables are the result of a correlation of the items in Nicaragua's GATT Schedule with tariff numbers now used by Nicaragua, i.e. the tariff items contained in the Arancel de Aduanas Centroamericano.

There are several problems involved in obtaining a correlation of this nature. The Nicaraguan tariff numbers in the GATT Schedule were based on the Standard International Trade Classification (SITC) at the seven or nine digit level. The new Arancel is also based on the SITC, but frequently the numbers used vary between Nicaragua's tariff and the Central American tariff. Thus, it is possible for two Nicaraguan tariff numbers to be incorporated into one Central American number or vice versa. The duties used in both tariffs are a combination of specific and ad valorem rates. Where both parts of the tariff decrease or increase in the Central American tariff when compared to the Nicaraguan tariff, it is an easy matter to indicate that the new rate is lower or higher than the rate in the Nicaraguan GATT Schedule. This procedure was followed in the two tables which list "Items Which Decrease" (Table I) and "Items Which Increase" (Table II). When the two parts of the two tariffs have moved in different directions, it is necessary to compute the ad valorem equivalent (A.V.E.) of the two rates and compare the resulting percentages. For example, Nicaraguan tariff item No. 753-01-01 was dutiable at \$0.40 + 10 per cent while the Central American rate is now Free + 25 per cent. The specific portion of the tariff has dropped to zero, but the ad valorem rate has increased by 15 percentage points. To determine the direction of the change in duty, the ad valorem equivalents of the two specific portions of the tariff were computed by:

- (1) determining the unit value of the goods imported, i.e.

$$\frac{\text{Value of imports}}{\text{Quantity of imports}} = \text{Unit Value}$$

- (2) obtaining the ad valorem equivalent, i.e.

$$\frac{\text{Specific duty}}{\text{Unit value}} = \text{A.V.E. of specific duty}$$

Then the total A.V.E. was obtained as follows:

$$\text{A.V.E. of specific duty} + \text{Ad valorem duty} = \text{Total A.V.E.}$$

If Nicaraguan statistics include data on duty collected at the seven digit level, an alternative means of obtaining an A.V.E. would be:

$$\frac{\text{Value of duty collected}}{\text{Value of imports}} = \text{Total A.V.E.}$$

After computing the A.V.E. of both the new and the old tariff, using for both the same year's value and quantity data, it is possible to ascertain for any item the direction of the change in its rate of duty.

This was done for a number of items where the trade data supplied by SIECA<sup>1</sup> in the Tercer Compendio Estadistico Centroamericano allowed exact comparison between the Nicaraguan tariff items and the Arancel Centroamericano. These items, with the A.V.E.'s in parenthesis, are found at the end of the Tables I and II.

Two other tables list items whose duties do not change (Table III) and items which have not yet been negotiated by the Central American Common Market (Table IV).

The trade statistics given in the tables are only exact when all numbers that is, the previous Nicaraguan tariff number, the current Nicaraguan tariff number, i.e., the Central American (NAUCA) tariff number, and the NAUCA statistical number are the same. Where one or more of the tariff numbers are broken down to the nine digit level the SIECA trade statistics can only provide an estimate of the trade involved.

A table summarizing the estimates of trade values involves in the various tables and the number of tariff items in each category is attached.
