#### PROVISIONAL ACCESSION OF ICELAND, TUNISIA AND YUGOSLAVIA

The Declarations which provide for the provisional accession of Iceland, Tunisia and Yugoslavia will expire on 31 December 1965. The Council of Representatives, at its meeting on 14 December, decided to prepare a procèsverbal to extend each of these Declarations for a further period. The texts are reproduced herewith. The three procès-verbaux are now open for acceptance at the office of the secretariat. They can be accepted by signature or by letter addressed to the Director-General by the Head of State, the Head of Government or the Foreign Minister.

Attention is drawn to the importance of early acceptance of these new instruments in order to avoid a lapse of contractual commitments between the provisionally acceding governments and the other parties to the Declarations.

# PROCES-VERBAL EXTENDING THE DECLARATION ON THE PROVISIONAL ACCESSION OF ICELAND TO THE GENERAL AGREEMENT ON TARIFFS AND TRADE

The parties to the Declaration of 5 March 1964 on the Provisional Accession of Iceland to the General Agreement on Tariffs and Trade (hereinafter referred to as "the Declaration" and "the General Agreement", respectively),

ACTING pursuant to paragraph 4 of the Declaration,

AGREE that:

- 1. The period of validity of the Declaration is extended for two years by changing the date in paragraph 4 to  $^{n}$ 1 December 1967 $^{n}$ .
- 2. This Proces-Verbal shall be deposited with the Director-General to the CONTRACTING PARTIES to the General Agreement. It shall be open for acceptance, by signature or otherwise, by Iceland and by the participating governments to the Declaration. It shall become effective between the Government of Iceland and any participating government as soon as it shall have been accepted by the Government of Iceland and such government.
- 5. The Director-General shall furnish a certified copy of this Procès-Verbal and a notification of each acceptance thereof to the Government of Iceland, to each contracting party to the General Agreement, to each government which has acceded provisionally thereto and to each government which enters into negotiations for accession.

DONE at Geneva this fourteenth day of December, one thousand nine hundred and sixty-five, in a single copy in the English and French languages, both texts being authentic.

#### THIRD PROCES-VERBAL EXTENDING THE DECLARATION ON THE PROVISIONAL ACCESSION OF TUNISIA TO THE GENERAL AGREEMENT ON TARIFFS AND TRADE

The parties to the Declaration of 12 November 1959 on the Provisional Accession of Tunisia to the General Agreement on Tariffs and Trade (hereinafter referred to as "the Declaration" and "the General Agreement", respectively),

ACTING pursuant to paragraph 6 of the Declaration,

AGREE that:

- 1. The validity of the Declaration is extended for a further two years by changing the date in paragraph 6 to "51 December 1967".
- 2. This Proces-Verbal shall be deposited with the Director-General to the CONTRACTING PARTIES to the General Agreement. It shall be open for acceptance, by signature or otherwise, by Tunisia and by the participating governments to the Declaration. It shall become effective between the Government of Tunisia and any participating government as soon as it shall have been accepted by the Government of Tunisia and such government.
- 5. The Director-General shall furnish a certified copy of this Procès-Verbal and a notification of each acceptance thereof to the Government of Tunisia, to each contracting party to the General Agreement, to each government which has acceded provisionally thereto and to each government which enters into negotiations for accession.

DONE at Geneva this fourteenth day of December one thousand nine hundred and sixty-five in a single copy in the English and French languages, both texts being authentic.

## PROCES-VERBAL EXTENDING THE DECLARATION ON THE PROVISIONAL ACCESSION OF YUGOSLAVIA TO THE GENERAL AGREEMENT ON TARIFFS AND TRADE

The parties to the Declaration of 13 November 1962 on the Provisional Accession of Yugoslavia to the General Agreement on Tariffs and Trade (hereinafter referred to as "the Declaration" and "the General Agreement" respectively),

ACTING pursuant to the fourth paragraph of the Declaration,

AGREE that:

- 1. The period of validity of the Declaration is extended by changing the date in the fourth paragraph to "50 June 1966".
- 2. This Proces-Verbal shall be deposited with the Director General to the CONTRACTING PARTIES to the General Agreement. It shall be open for acceptance by signature or otherwise, by Yugoslavia and by the participating governments to the Declaration. It shall become effective between the Government of Yugoslavia and any participating government as soon as it shall have been accepted by the Government of Yugoslavia and such government.
- 5. The Director-General shall furnish a certified copy of this Procès-Verbal and a notification of each acceptance thereof to the Government of Yugoslavia, to each contracting party to the General Agreement, to each government, which has acceded provisionally thereto, and to each government which enters into negotiations for accession.
