Communication of Information from Sweden

By letter of 19 January 1984, the delegation of Sweden has submitted the following information on: (i) Values of Service Procurement by Sweden during fiscal year 1982/83 (1 July-30 June); (ii) Specific Derogations; and (iii) Non-Code Covered Entities.

¹The following government business entities are not reporting under the computerized government accounting system and it has therefore not proved feasible to include them in the above statistics: National Industries Corporation, Post Office Administration, Swedish Forest Service, National Civil Aviation Administration, National Telecommunications Administration, National Railways and the State Power Board. The total procurement of services by these seven entities reached SDR 1.25 billion in FY 81/82. The first four of the seven entities mentioned are currently code covered.

II. SPECIFIC DEROGATIONS

The Swedish Government has during the 1981-83 period applied note 2 of the list of Swedish entities in Annex 1 of the Agreement in connection with one procurement. The procurement in question was for winter overalls and made by the Post Office Administration. The value involved was approximately SDR 300,000. The decision by the Government on 13 June 1983, was made within the framework of a supply security support programme for the Swedish textile industry.

III. NON-CODE COVERED ENTITIES
