The following communication has been received from the permanent delegation of the Commission of the European Communities by letter dated 24 June 1985.

"In compliance with the Community's obligations under Article IX, paragraph 5(a) of the Agreement on Government Procurement, I attach a rectification to the entity list of the French Republic.

In response to requests for further clarification regarding a recent rectification to the entity list of the Kingdom of the Netherlands, I also attach an explanatory note regarding this matter.

I would be grateful if you would arrange for the circulation of these rectifications to the Committee on Government Procurement."

FRENCH REPUBLIC

It is only a purely formal rectification, taking account of the new delimitation of the various Ministries introduced in July 1984 after a new Government took office.

This delimitation does not in any way alter the aggregate value of the concessions made by the French Republic when the Code was negotiated in 1979-80.

THE REVISED ENTITY LIST OF THE NETHERLANDS

The second footnote introduced in the revised entity list of the Netherlands in respect of the Ministry of Defence does not in any way constitute a modification to the total value of the original concessions made by the Netherlands.

It has been introduced purely for information to indicate that the Ministry of Defence itself directly undertakes procurement on behalf of the land-forces (landmacht), while that of the air and maritime forces continues as before to be carried out by the separate procurement offices shown in Section B of the list, namely the Air Material Directorate and Procurement Division of the Royal Netherlands Navy.
