On page 9, under the section: 5. Dispute Settlement, the entire
paragraph should be deleted and replaced by:

"Consultations between the delegations of the United States and
Spain held in 1984 and 1985 under Article 14.1 of the Agreement were
suspended in April 1985 pursuant to the type approval by Spain of
electrical medical equipment of one producer in the United States.
However, the delegation of the United States reserved the right to take
future action in the event of any failure by the Spanish authorities to
approve applications submitted by other producers in the United States."

On page 11, the information on the number of enquiries received by the European Economic Community in 1983 should be deleted and replaced by:
