RECTIFICATIONS OF A PURELY FORMAL NATURE AND
MINOR AMENDMENTS RELATING TO ANNEX I TO
THE AGREEMENT ON GOVERNMENT PROCUREMENT

AUSTRIA

The secretariat has received the following communication from the delegation of Austria, notifying rectifications and amendments under Article IX, paragraph 5(a), of the Agreement on Government Procurement. In accordance with this provision, they shall become effective, provided there is no objection within thirty days.

I have been instructed to notify, according to Article IX:5(a) of the Agreement on Government Procurement, a number of rectifications of a purely formal nature in the List of Austrian Entities referred to in Article I, paragraph 1(c), which are listed below.

This notification exclusively concerns changes in addresses, in names of federal ministries, as well as organizational rearrangements and improvements in translation. A typical example is the merger of two federal ministries into a newly named one referred to in items 3 and 6 of the list. None of the modifications notified impairs or reduces the coverage of the entities or changes in any way the balance or rights and obligations.
